Field strengths from fixed transmitters, such as base stations for radio (cellular / cordless) telephones and land mobile radios, amateur radio, AM and FM radio broadcast and TV broadcast cannot be predicted theoretically with accuracy.

To assess the electromagnetic environment due to fixed RF transmitters, an electromagnetic site survey should be considered. If the measured field strength in the location in which the INQUA® NEB plus is used exceeds the applicable RF compliance level above, the INQUA® NEB plus should be observed to verify normal operation.

If abnormal performance is observed, additional measures may be necessary, such as reorienting or relocating the INQUA $^{\otimes}$ NEB plus .

Over the frequency range 150 kHz to 80 MHz, field strengths should be less than 10 V/m.

The customer or user of the INQUA® NEB plus can help prevent electromagnetic interference by maintaining a minimum distance between portable and mobile RF communication equipment (transmitters) and the INQUA® NEB plus as recommended below, according to the maximum output power of the communications equipment.
